Since 1924, the Clarendon Chamber of Commerce has worked to promote the development of commercial, agricultural, and tourism opportunities in Clarendon and Donley County. The Chamber is governed by a ninemember board from which is elected a president and vice president. A Manager, hired by the board, oversees the daily operations of the Chamber.

THE CLARENDON VISITOR CENTER: The

Chamber of Commerce, in cooperation with the Clarendon Economic Development Corp. (CEDC), operates the city's official visitor center located in downtown Clarendon at the historic Mulkey Theatre. The Visitor Center is open daily, Monday-Friday, and serves to welcome visitors to our community as well to provide information about Clarendon and Donley County to those passing through. Chamber and CEDC personnel also respond to requests for information over the telephone, through email, and via social media. The Visitor Center also distributes local maps, phone books, and city brochures.
